ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION of 82 APR 6 PM 4:15

Pursuant to the provisions of §30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Gold Grabber Manufacturing, Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on the <u>31st</u>day of <u>March</u>, 1982, in the manner prescribed by the Idaho Business Corporation Act:

"FOURTH

"The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares of common stock with a par value of \$1.00 per share."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 5,000. The number of shares entitled to vote thereon was 5,000.
