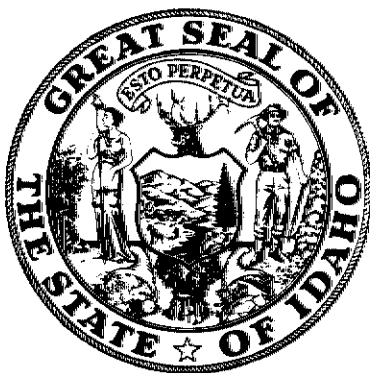

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
KOOSKIA, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is KOOSKIA, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on February 24, 1982, in the manner prescribed by the Idaho Business Corporation Act:

ARTICLE FIVE
AUTHORIZED CAPITAL STOCK

The authorized capital stock of this corporation shall be TWO MILLION DOLLARS (\$2,000,000.00), consisting of TWENTY THOUSAND (20,000) shares of stock at the par value of ONE HUNDRED DOLLARS (\$100.00) per share. There shall be but one class of stock.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was FIVE THOUSAND (5,000); and the number of shares entitled to vote thereon was FIVE THOUSAND (5,000).

FOURTH: The number of shares voted for such amendment was FIVE THOUSAND (5,000); and the number of shares voted against such amendment was none.

FIFTH: The manner in which such amendment effects a change in the amount of stated capital and the amount of stated capital is changed by such amendment, are as follows: the amendment changes the amount of stated capital from FIFTY THOUSAND DOLLARS (\$50,000.00) to TWO MILLION DOLLARS (\$2,000,000.00) which is done pursuant to 30-1-58 Subsections (d) and Subsection (e) which

increases the aggregate number of shares and increases the par value of the authorized shares.
