## ARTICLE I CORPORATION NAME

This corporation shall be known as Freater St. Maries Youth Soccer Association, Inc.

### ARTICLE II NONPROFIT STATUS

Greater St. Maries Youth Soccer Association is a nonprofit corporation. No part of the income of the corporation may be distributed to the members, directors, or officers of the corporation. Reasonable compensation for services rendered, payment of benefits in conformity with the purposes of the corporation and reimbursement of expenses may be paid to members, directors, or officers only insofar as consistent with the Idaho Code Title 30, Chapter 3, and the provision of Sections 170(c) (2) and 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law).

## ARTICLE III DURATION OF CORPORATION

The duration of Greater St. Maries Youth Soccer Association shall be perpetual.

### <u>ARTICLE IV</u> . CORPORATE PURPOSES

Greater St. Maries Youth Soccer Association is organized exclusively for charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under Section 501 (c) (3) of the Internal revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) by an organization contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).

Upon dissolution of this organization, assets shall be distributed to nonprofit organization having tax exempt status under Section 501 (c) (3) of the Internal Revenue Code for one or more exempt purposes within the meaning of said Internal Revenue Code (or corresponding provision of any future tax code), or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas in the County in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized exclusively for such purposes.

This corporation is organized for the purpose of organizing soccer teams for youth as an alternative to other less desirable activities.

# ARTICLE V CORPORATE POWERS

Subject to any limitations and conditions which are or may be prescribed by law, or in these Articles of Incorporation, or in the Bylaws of this corporation, Greater St. Maries Youth Soccer Association shall have all powers which are now or hereafter conferred by law upon a corporation organized under Idaho Code Title 30, Chapter 3.
