AQUA GENETICS, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for this corporation:

I. The name of this corporation shall be Agua Genetics, Inc.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The address of the initial registered office of this corporation is 4740 Umatilla, Boise, Idaho 83709, and the name of the initial registered agent at such address is Michael Sipe.

IV.

The nature of the business and the object and purpose of this corporation shall be as follows: Research and development of growth of fish, and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
