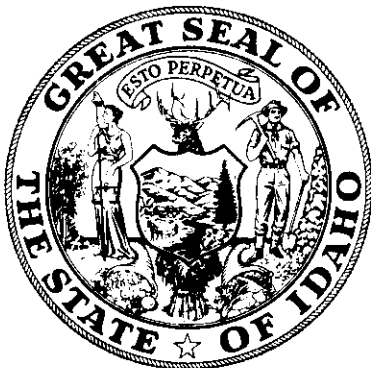

ARTICLES OF INCORPORATION
OF
CHEMICAL-ALCOHOL REHABILITATION RESEARCH AND
EDUCATION FOUNDATION, INC.

The undersigned, acting as incorporator under the provisions of the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation.

I.

NAME

The name of the corporation is Chemical-Alcohol Rehabilitation Research and Education Foundation, Inc.

II.

DURATION

The period of its duration shall be perpetual.

III.

PURPOSES

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Idaho Nonprofit Corporation Act for public and charitable purposes. The public

and charitable purposes of the corporation are to operate a nonprofit organization to provide drug and alcohol counseling, research and education.

IV.

MEMBERSHIP

The corporation shall have one class of members only. The authorized number, if any, and qualifications of members of the corporation, the filling of vacancies and all rights, privileges and duties, if any, shall be as stated in the Bylaws. The management of the affairs of the corporation shall not be vested in the members pursuant to Section 30-314(c), Idaho Code, but shall be vested in the Board of Directors whose authority is granted or limited to the extent stated in the Bylaws.

V.

REGISTERED OFFICE

The address of the initial registered office of the corporation is Post Office Box 513, Sun Valley, Idaho 83353.

VI.

REGISTERED AGENT

The name of the initial registered agent of the corporation, at the above address is, Wendell D. Nelson.

VII.

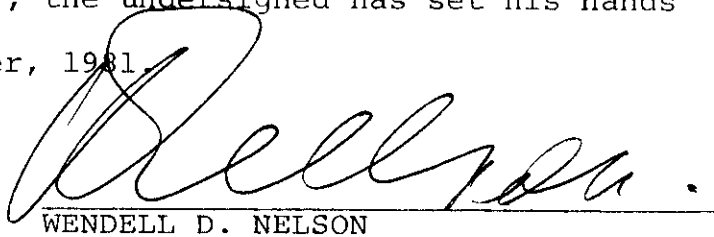

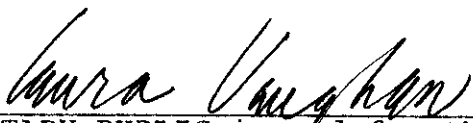
