ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
SOUTHWEST PIPE OF IDAHO, INC.

Southwest Pipe of Idaho, Inc., a corporation of the State of Idaho, certifies that pursuant to a Consent of Stockholders to Amendment of Articles of Incorporation signed by all of the stockholders of the corporation, dated the 27th day of February, 1968, it was agreed and adopted that Article FIFTH of the Articles of Incorporation which provided:

"The total number of shares of stock which the corporation shall have authority to issue shall be five thousand (5,000), of the par value of Ten Dollars (\$10.00) each, amounting in the aggregate to Fifty Thousand Dollars (\$50,000.00),"

be amended as follows:

"The total number of shares of stock which the corporation shall have authority to issue shall be ten thousand (10,000), of the par value of Ten Dollars (\$10.00) each, amounting in the aggregate to One Hundred Thousand Dollars (\$100,000.00)."
