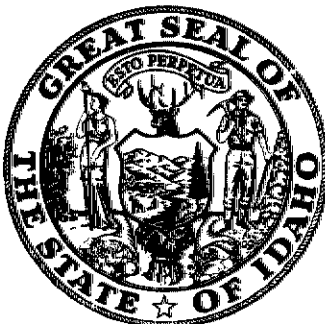

ARTICLES OF INCORPORATION

FIRST: The name of the corporation (which is hereinafter called the Corporation),
is INSTANT SHADE, INC.

SECOND: The duration of the Corporation shall be perpetual.

THIRD: The purpose for which the Corporation is formed is as follows: RETAIL AND WHOLESALE SALE AND INSTALLATION OF MATURE TREES.

FOURTH: The total number of shares of stock which the Corporation has authority to issue is 10,000 SHARES of no par value per share, all of one class.

FIFTH: The post office address of the registered office of the Corporation in Idaho is 1589 N DUNSMUIR WAY, EAGLE, IDAHO 83616. The name and post office address of the registered agent of the Corporation in Idaho are WILLIAM WITHERS, 1589 N DUNSMUIR WAY, EAGLE, IDAHO 83616.
