KNOW ALL MEN BY THESE PRESENTS:

We, the undersigned natural persons of the age of 21 years or more, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

# ARTICLE I.

# NAME

The name of corporation is J & R FENCE COMPANY, INC.

# ARTICLE II.

#### DURATION

The period of duration of the corporation shall be perpetual.

# ARTICLE III.

#### PURPOSES AND POWERS

2. To generally engage in, do and perform any enterprise, act or vocation that a natural person might or could do or perform.

3. To engage in the manufacture, sale, purchase, importing and exporting of merchandise and personal property of all matter and description, to act as agents for the purchase, sale, handling of goods, wares and merchandise of any and all types and descriptions for the account of the corporation or as factor agent, procurer or otherwise for or on behalf of another.

4. SECTION 1. Description and Classes of Shares: There shall be one class of shares, all of which shall be common stock.
