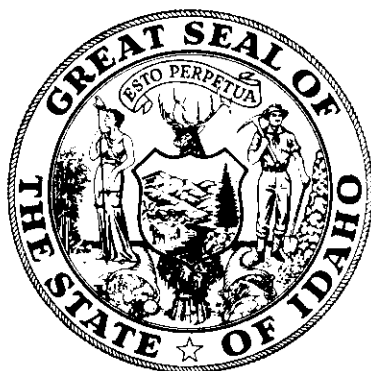

The undersigned Officers, being the President and Secretary, of CAMP PROPERTY, INC., do hereby certify that a meeting of the Board of Directors of CAMP PROPERTY, INC., was held at The Westin Bonaventure, Fifth and Figueroa Streets, Los Angeles, California on June 15, 1982. That said Special Board of Directors Meeting was attended by a majority of directors of the Company. That at said meeting the directors were informed that application for corporation reinstatement for Camp Property, Inc. had been applied for with the Idaho Department of State. That at said meeting, the following Resolutions were unanimously approved by those in attendance:

"BE IT HEREBY RESOLVED that application for corporation reinstatement for Camp Property, Inc. be approved and filed with the Idaho Department of State."

"BE IT HEREBY RESOLVED that the Articles of Incorporation be amended and that Article FIRST which presently provides:

`FIRST: The name of the Corporation is
Camp Property, Inc.'

shall be amended and as amended shall read
as follows:

`FIRST: Upon reinstatement of the Corporation,
the name of the Corporation shall
be Camp Inc.'

"BE IT FURTHER RESOLVED that the Officers of the Company shall execute the necessary Articles of Amendment and file the same with the Secretary of the State of Idaho."

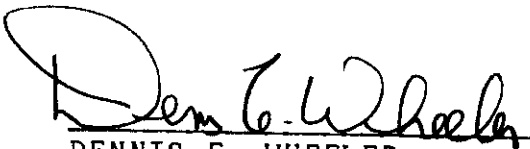

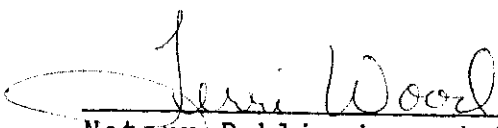
