ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF PAGOSA SPRINGS TELEPHONE CO., INC.

The undersigned, PAGOSA SPRINGS TELEPHONE CO., INC., for the purposes of amending its Articles of Incorporation and pursuant to the provisions of Section 30-147 the Idaho Business Corporation Act, hereby executes the following Articles of Amendment:

Article One: The name of the corporation is Pagosa Springs Telephone Co., Inc.

Article Two: The following amendments were adopted in the manner prescribed by "The Business Corporation Act of Idaho":

RESOLVED, that Section V of the Articles of Incorporation is amended by deleting it in its entirety and substituting the following:

Section V.

The total authorized number of shares of stock and the par value thereof are as follows:

RESOLVED, that Section VI of the Articles of Incorporation is amended by deleting it in its entirety and substituting the following:

"No shares of stock heretofore or hereafter authorized or heretofore or hereafter issued shall have preemptive rights."

RESOLVED, that Section VIII of the Articles of Incorporation is amended by deleting it in its entirety and substituting the following:

"That all meetings of the Board of Directors may be held at the principal office of the corporation in this State or at such other place or places within or without this State for the transaction of any business of the corporation as the Directors may by resolution or by the By-Laws provide."

Article Third: Prior to the aforesaid Amendments, the corporation was authorized to issue the following shares:

At the time of the aforesaid amendment and at the present time there were and are no issued and outstanding shares of Preferred stock of any type.

Article Fourth: The capital stock and capital of said corporation will not be reduced under or by reason of these amendments.
