### **ARTICLE V-PURPOSES**

This organization is organized exclusively for charitable, religious, educational, and scientific purposes under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Furthermore this organization shall strive:

- A. To support or present artistic events of excellence in the greater Eagle, Idaho area (Treasure Valley) that contribute to the quality of life in the community.
- B. To support or present arts education programs for the public's benefit.
- C. To establish and support an arts facility in the greater Eagle, Idaho area which will contribute to the quality of life in the community.
- D. Support the programs of the Eagle City Arts Commission
- E. To exercise all powers granted by law necessary and proper to carry out the forgoing purposes, including, but not limited to, the power to accept donations of money, property, whether real or personal, or any other things of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefore, may not at that time lawfully carry on or do.

### ARTICLE X – DISTRIBUTION ON DISSOLUTION

Upon dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
