ARTICLES OF INCORPORATION

FIRST

The name of this corporation shall be The Grace Bible Church, Incorporated.

SECOND

The object of this corporation shall be to acquire, hold and dispose of real and personal property for the benefit of the members of The Grace Bible Church, Incorporated, residing in the County of Canyon and State of Idaho, for works of charity and for public worship.

THIRD

The estimated value of our property for which a warranty deed is being held in escrow at Provident Federal Savings and Loan, Nampa, Idaho, at the time of making these Articles of Incorporation, is Sixteen Thousand Five Hundred Dollars.

FOURTH

The title of the person making these Articles of Incorporation is, Pastor of The Grace Bible Church, Incorporated, in the County of Canyon and State of Idaho.
