To the Secretary of State of the State of Idaho

Pursuant to Title 30, Chapter 3, Idaho Code, the undersigned non-profit corporation amends its articles of incorporation as follows:

### Article 2

Said Organization is organized exclusively for charitable, religious, educational, an scientific puposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under sections 501 (c)(3) of the Internal Revenue Service code, or corresponding sections of any future federal tax code.

### Article 8

Upon the dissolution of the organization, assets shall be distributed for one or more exempt puposes within the meaning of sections 501 (c)(3) of the Internal Revenue Service code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not diisposed of shall be disposed of by a court of competent jurisdiction. see attachment
