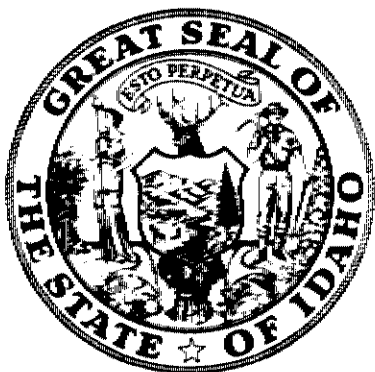

ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION
OF
STOKES SPRINKLING, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, as follows:

FIRST: The name of the corporation is Stokes Sprinkling, Inc.

SECOND: The following Amendment of the Articles of Incorporation were adopted by the Shareholders of the corporation on the 1st day of February, 1989:

1. That the name of the corporation shall now be:
SUNSHINE SPRINKLING SYSTEMS, INC.
2. That the purposes of the corporation shall be broadened to include the transaction of any or all lawful business for which corporations are incorporated under the Idaho Business Corporation Act.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 100,000; and the number of shares entitled to vote thereon was 100,000.

FOURTH: The voting for such amendment was unanimous; and

the number of shares voted against such amendment was nil.
