### CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

**FOGATELLA SWIDENSON CLUB, INC.**

was filed in the office of the Secretary of State on the **Thirty-first** day of **December,** A. D. One Thousand Nine Hundred **Sixty-three** - and is duly recorded on Film No. **126** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **Ninety-nine years** from the date hereof, with its registered office in this State located at **Fogastelle** in the County of **Bannock,** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION  
OF  
POCATELLO GRIDIRON CLUB, INC.

KNOW ALL MEN BY THESE PRESENTS, that the undersigned residents of the State of Idaho and natural persons over the age of twenty-one years, have associated, and do hereby associate themselves together for the purpose of forming a non-profit corporation under the laws of the State of Idaho made and provided therefore.

ARTICLE I

The business and purpose of such corporation shall be to aid and assist in the education of and the advancement of the spiritual and physical welfare of high school and college students and to aid in the education of all deserving young men and women of the State of Idaho in every way possible and by granting of scholarships to those found worthy thereof; in aiding and assisting in building and preserving the highest physical standards in the youth of America; the physical conditions of said youth being of importance to the welfare of our government and the carrying out of the purposes and objectives hereof in any manner or means that may seem to the Board of Directors of this association from time to time, to be best adapted to the furtherance of said purposes.

ARTICLE II

The name of said corporation shall be POCATELLO GRIDIRON CLUB, INC., and its location shall be in Pocatello, Bannock County, Idaho.

### ARTICLE III

This corporation is one which does not contemplate pecuniary gain or profit to the members thereof and is organized for non-profit purposes and no part of any net earnings thereof shall inure to the profit of any member or other individual.

### ARTICLE IV

The general officers of the corporation shall consist of a President, Vice-President, Secretary, and Treasurer. The number of directors shall consist of no less than three nor more than thirty five.

### ARTICLE V

The conditions and regulations of membership and the rights or other privileges or class of members shall be determined and fixed by the by-laws. This corporation formed hereby shall have no capital stock, and shall be composed of members rather than share holders.

### ARTICLE VI

The private property of the members of this corporation shall not be liable for its corporate debts.

### ARTICLE VII

The objectives of this corporation shall be to receive gifts and grants of money and property of every kind and to administer the same for the educational, civic and philanthropic uses and to do anything necessary or proper for the accomplishment of these purposes.

### ARTICLE VIII

To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes or the attainment

of any of the objects or the furtherance of any of the powers hereinbefore set forth, with, alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things incidental or pertinent to or growing out of or connected with the aforesaid objects or purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized.

#### ARTICLE IX

The condition of membership is any person of good character being proposed for membership and accepted by either the general membership or Board of Directors by majority vote of either and payment of the membership fee as fixed from time to time by the Board of Directors.

#### ARTICLE X

The term for which this corporation is to exist is ninety-nine years unless previously dissolved in accordance with the law of the State of Idaho.

#### ARTICLE XI

That there was heretofore published in the Idaho State Journal, a daily newspaper in the City of Pocatello, Bannock County, Idaho, for two consecutive weeks a notice of time and place for holding a meeting for the purpose of incorporating as a non-profit corporation in accordance with Chapter 11, title 30, I.C.A. and in accordance with the laws made and provided therefore an election was held in accordance with said notice in the Bannock Hotel, Pocatello, Bannock County, Idaho, at 12:00 o'clock noon, December 30 wherein a majority of the membership present voted to so incorporate and elected a Board of Directors in accordance with the laws made and provided therefore.
