ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FIRST METHODIST CHURCH OF BOISE CITY

These Articles of Amendment and certificate thereon are made and executed pursuant to Section 30-1103, Idaho Code, for the purpose of amending the Articles of Incorporation of FIRST METHODIST CHURCH OF BOISE CITY, an Idaho corporation, to change the name from "FIRST METHODIST CHURCH OF BOISE CITY" to "FIRST UNITED METHODIST CHURCH OF BOISE CITY".

The undersigned, Russell M. Ash, President of the Board of Trustees, and Marcel Learned, Secretary of the Board of Trustees, do hereby respectfully certify as follows:

Ι.

That a regular meeting of the members of the First Methodist Church of Boise City, an Idaho corporation, was held at 11th & Franklin Street, Boise, Idaho, on Sunday, November 24, 1968, at the hour of 12:00 o'clock noon, pursuant to notice given by publication in The Intermountain Observer, a newspaper published in Ada County, Idaho, for four (4) successive weeks, to wit: October 26, November 2, November 9 and November 16, all in 1968, all as provided in Idaho Code Section 30-1103.

II.

That at said meeting the following resolution was unanimously adopted:

BE IT RESOLVED That the corporate name of the First Methodist Church of Boise City be, and the same is hereby, changed to "FIRST UNITED METHODIST CHURCH OF BOISE CITY".

We further certify that Russell M. Ash is the president and Marcel Learned is the secretary of the Board of Trustees of said corporation and we, therefore, execute these Articles of Amendment to the Articles of Incorporation of said corporation.
