Articles Of Incorporation

We, the undersigned natural persons of the age of twentyone years or more, at least two of whom are citizens of the
State of Idaho, noting as incorporators of a corporation under
the Non-Profit Corporation Act, do hereby adopt the following
Articles for such corporation.

ARTICLE I

The name of the corporation is: The American Legion, Priest River Post #147 of the Department of Idaho, Incorporated.

ARTICLE II

The corporation is a non-profit corporation.

ARTICLE III

The period of its duration is perpetual.

ARTICLE IV

The purpose for which the corporation is organized is: To uphold the Constitution and laws of the United States, to realize the American ideals and aims for which those eligible to membership fought, to advance the interest and work for the betterment of all wounded, injured, gassed disabled, and all veterans, to cooperate with the United States Veterans Administration and all other public and private agencies devoted to the cause of improving and advancing the condition, health, injured, wounded, disabled and all other veterans, to serve our comrades, our communities and our country and to encourage in all people the spirit of understanding which will guard against future wars. corporation is limited to such as will qualify it as an exempt organization corporation will not, as a substantial part of its activities carry on propaganda or otherwise attempt to influence legislation. This corporation shall not participate in or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public offices.

ARTICLE V

This corporation recognizes the National Organization, known as The American Legion, incorporated by Act of Congress, and affirms its allegiance, subordination, to the said National Organization, its Constitution, By-laws and all rules, mandates and regulations promulgated pursuant thereto, approved by Congress of the United States of America of September 16, 1919 and all amendatory acts thereto.

ARTICLE VI

The Incororation of The American Legion Priest River Post #147 will follow the amended section enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That section 3 of the act entitled "An Act to Incorporate The American Legion," approved September 16, 1919 (41 Stat. 285, title 36, U. S. C. 1940 edition, sec. 43) is hereby amended to read as follows:

Amended Section

"Sec. 3. That the purpose of this incorporation shall be; To uphold and defend the constitution of the United States of America; to promote peace and good will among the peoples of the United tates and all the nations of the earth; to preserve the memories and incidents of the two World Wars and the other great hostilities fought to uphold democracy; to cement the ties and comradship born to service; and to consecrate the efforts of its members to mutual helpfulness and service to their country."

ARTICLE VII

The address of the initial registered office of the corporation is: The American Legion, Preist River Post #147, Box 927. Preist River, Idaho 83856.

The street address of the initial registered office is 216

Main Street, Preist River, Idaho.

The name of the initial registered agent at said address is, Ernest A Olson.

ARTICLE VIII

Upon dissolution of the Corporation, the assets remaining after payment of its debts, shall be distributed as provided by the National Constitution and By-laws.
