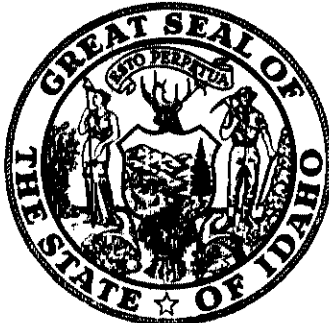

To the Secretary of State of the State of Idaho:

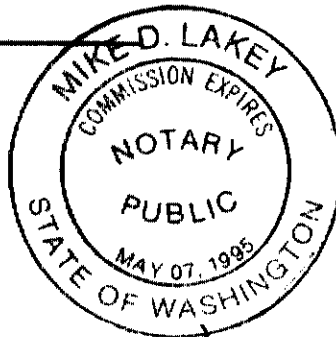
