KNOW ALL MEN BY THESE PRESENTS: That we, HOLMES B. GABBERT and GRETA E. GABBERT of Council, Adams County, Idaho, and N. G. SPEROPULOS of Weiser, Washington County, Idaho, all being citizens of the United States of America, and all being of full age, do, under and in pursuance of the General Incorporation Laws of the State of Idaho, hereby voluntarily associate ourselves together, and such other persons as hereafter may become associated with us, into a body politic and corporate, to carry on the business and for

the purposes hereinafter named:

The name of this Corporation shall be 7 DEVILS CATTLE CO.

II.

The purposes for which this corporation is formed are as follows, to-wit:

- To operate, carry on and maintain a specialized and general farming and ranching operation or (a) operations, and to carry on such business in all its interrelated or allied aspects.
- (h) To operate, carry on and maintain a general livestock business, including buying, selling, feeding, producing and raising of livestock, and to carry on such a business in all its interrelated or allied aspects.
- (c) To operate, carry on and maintain the business of buying, selling and servicing any and all types of farm machinery and equipment, power tools, hand tools, hardware, of any and all types, makes and kinds of goods, wares and merchandise, and to carry on such business with all of its interrelated or allied aspects.
- (d) To have and to use a corporate seal which may be altered at pleasure.
- To receive, acquire, hold, purchase, dispose of, convey, mortgage and/or lease real and personal (e) property; to dispose of, sell, lease, assign, transfer, mortgage and/or convey any rights, privileges, franchises, real or personal property

of the corporation, other than its franchise of being a corporation, and to acquire, purchase, 1 guarantee, hold, mortgage, own, vote, sell, 2 pledge and/or otherwise dispose of and deal in 3 shares, bonds, securities and debentures and other evidences of indebtedness of other 4 corporations, domestic or foreign. 5 (f) To appoint such officers, employees and agents as the business of the corporation may require and to 6 allow them compensation. 7 (g) To enter into contracts or obligations of any kind or type essential, necessary or proper to the transactions of its ordinary affairs or 8 for the purpose of the corporation. 9 To conduct business in the State of Idaho or (h) 10 other states and territories of the United States and in foreign countries and to have 11 one or more offices and places of business in or out of the State of Idaho and to acquire, receive, hold, purchase, lease, mortgage, dispose of and/or convey real and personal 12 13 property situate within or without the State of Idaho. 14 To apply for, acquire, hold, use, own, operate, dispose of by sale, or otherwise, mortgage, hypothecate, lease and/or sell and grant (i) 15 16 licenses in respect of patents, trade marks, trade names, inventions, improvements, 17 processes, copyrights and licenses therefor. 18 (j) To execute, issue, negotiate promissory notes, bills of exchange, bonds, debentures, negotiable instruments, securities and other obli-19 gations of the corporation and to secure any 20 of the same by pledge, mortgage, deeds of trust or other hypothecation of any/or all of 21 the property of the corporation. 22 In connection with the carrying on of the business of the corporation, to lend and (k) 23 advance money, credit, property of the corporation and to render aid by guarantee or 24 in any other manner gratuituously or on such terms as may seem expedient on open account, 25 secured or unsecured, to any person, firm, association or corporation. 26 To purchase, subscribe for or otherwise acquire, own, manage, hold, use, operate, lease, mort-gage, hypothecate, pledge, exchange, assign, (1) 27 28 transfer, sell or otherwise dispose of immovable and movable property of every kind and descrip-29 tion, including shares of stock, bonds, indentures, notes, evidences of indebtedness and other securities, contracts or obligations of this or any other corporation, association or 30 31 firm, and to pay therefor in whole or in part in cash or by exchanging therefor stocks, bonds or other evidence of indebtedness or securities 32

of this or any other corporation and to receive, 1 collect and dispose of the interest, dividends, and income arising from such property and to 2 possess and exercise in respect thereof all the 3 $oldsymbol{r}$ ights, powers and privileges of ownership, including all voting powers of any stocks or other securities so owned, controlled, managed 4 or operated. 5 (m) Generally to do any and all things necessary or 6 proper in carrying on the business of the corporation and to enter into, make, perform and carry out contracts, leases and franchises of

- every kind and nature relating to or connected with the business or any phase thereof in which the corporation may be or is from time to time engaged upon and to do everything necessary, proper or useful for the accomplishment of the objectives and principles herein enumerated, or necessary, proper or convenient to the benefit of the corporation for the furtherance of its business propositions.
- (n) The foregoing clauses are to be considered as objectives, purposes and powers and the enumeration of specific powers shall not limit or restrict in any manner the powers of the corporation, it being the intention that the objectives and powers specified in this or any other article herein shall in nowise be limited or restricted by reference to or by inference from the terms of any other article or clause thereof, but the same may be and is extended thereby.

III.

The principal place of the transaction of business of this corporation and its post office address and registered office shall be at Council, Adams County, Idaho, but the corporation may establish and maintain such subordinate and branch offices as may hereafter be decided or determined upon by the corporation, by or through its Board of Directors, whether in the State of Idaho, or such other states or places as may from time to time be determined.

IV.

That the period for which this corporation shall exist shall be perpetually, from and after the date of filing these Articles of Incorporation.

V.

That the total authorized capital stock of this corpor-
