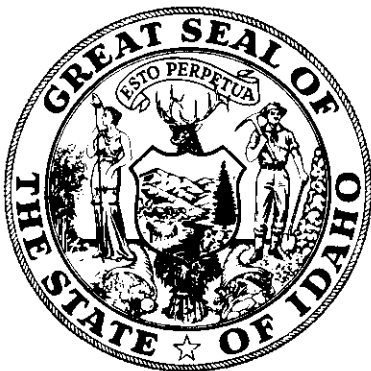

ARTICLES OF INCORPORATION
OF
NEW LIFE BIBLE FELLOWSHIP, INC.

ARTICLE ONE

Name

We, the undersigned, being three or more natural persons of full age, at least two-thirds of whom are citizens of the United States or of its territories or possessions, have this day voluntarily associated ourselves for the purpose of forming a private, non-profit corporation under the laws of the State of Idaho, and to that end hereby adopt articles of incorporation as follows:

ARTICLE TWO

Purpose

The purpose of this non-profit corporation is to glorify God. The means for accomplishing this purpose shall include, but not be limited to, establishing a Christian Fellowship, teaching Biblical truths, providing opportunities for Christian worship, and carrying out the Great Commission as stated in Matthew 28: 18-20. This corporation is organized exclusively for religious purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried out by an organization exempt from Federal income tax under same section.

ARTICLE THREE

Duration

This non-profit corporation shall continue perpetually in existence unless and until the following circumstance occurs: A simple majority of the members votes affirmatively to dissolve the corporation.

ARTICLE FOUR
Dissolution

Upon the occurrence of the event set out in Article Three, all assets belonging to this non-profit corporation shall be transferred to another Christian organization of similar purpose which has established exempt status under section 501(c)(3) of the Internal Revenue Code, as selected by the Elders of this non-profit corporation.
