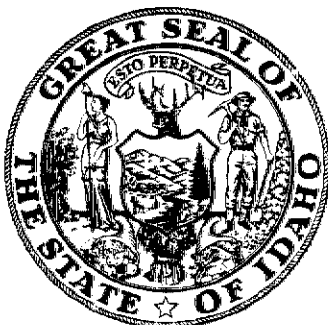

ARTICLES OF INCORPORATION  
OF  
A COMPANY OF WOMEN INTERNATIONAL, INC.

KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, being a neutral person of full age and a citizen of the United States, in order to form a corporation for the purposes hereinafter stated, and in accordance with and pursuant to Idaho Code 30-3-1 and the Idaho Nonprofit Corporation Act, do hereby certify as follows:

ARTICLE I.

The name of the corporation is A COMPANY OF WOMEN INTERNATIONAL, INC., and is a nonprofit corporation.

ARTICLE II.

The purposes for which said corporation is formed are:

1. To form a company of women of excellence from across the country and from all walks of life to study, teach, and spread God's Word.
2. To publish and distribute books, magazines, newsletters, and tapes to help minister God's Word.
3. The goal of the corporation is also to encourage, train, and assist women to use the many and varied gifts God has bestowed upon them in order to effectuate their evangelical pursuits.

4. To meet in a spirit of fellowship, love, and charity.

#### ARTICLE III.

The corporation will come into existence on the date of the issuance to it of a Certificate of Incorporation by the Secretary of State of the State of Idaho, and the duration of the life of this corporation shall be perpetual.

#### ARTICLE IV.

The location and post office address of the registered office, and the registered agent, of the corporation shall be:

#### ARTICLE V.

There shall be no members in the corporation.

#### ARTICLE VI.

The name and address of the individual who will serve as the initial director on the board of the corporation is:

This same named individual is the incorporator of said corporation, and her term as director will be specified in the by-laws.

#### ARTICLE VII.

In addition to the above named director, there shall be additional directors named in the by-laws who need not be residents of Idaho.


#### ARTICLE VIII.

The corporation reserves the right to amend, add to, or repeal any provisions contained in these Articles of Incorporation, in a manner consistent with the law and in conformity with the provisions to be set forth in the by-laws.

#### ARTICLE IX.

In the event of dissolution of the corporation, any assets remaining after payment of the corporation's debts, if any there be, will be distributed to a charitable organization or organizations as defined under Section 501(c)(3) of the Internal Revenue Code of 1954, or any subsequent statutes or regulations.

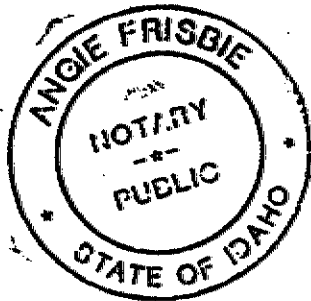
