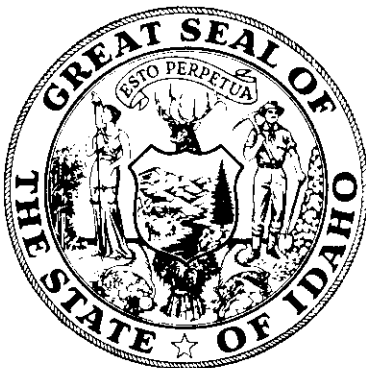

ARTICLES OF INCORPORATION
OF
SNAKE RIVER VALLEY MEDICAL CENTER, P.A.

The undersigned, acting as incorporator(s) of a corporation under the Professional Service Corporations Act, and licensed to practice medicine in the State of Idaho, adopt(s) the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of this corporation shall be SNAKE RIVER VALLEY MEDICAL CENTER, P.A.

ARTICLE II

PURPOSE

The purpose for which the corporation is formed, is as follows:

(A) To engage in and carry on the family practice of medicine through officers, employees and agents who are duly licensed and authorized to render medical services through licensing by the State of Idaho.

(B) To invest its funds in real estate, mortgages, stocks, bonds, or any other type of investment; to own real or personal property necessary for the rendering of professional legal services; and, in general, to carry on any business in connection with the practice of family medicine and incident thereto not forbidden by the laws of the State of Idaho, and with all powers conferred upon professional service corporations pursuant to the laws of the State of Idaho.

ARTICLE III

PLACE OF BUSINESS AND AGENT

The registered office of this corporation and the principal place for the transaction of its business is hereby designated as 126 West Short Street, Rigby, Idaho, 83442. The name of the registered agent is Russell E. Banks, at that address.

ARTICLE IV

EXISTENCE

The corporation shall have perpetual existence.

ARTICLE V

CAPITAL

The Aggregate number of shares which the corporation shall have authority to issue is Ten Thousand (10,000) shares having no par value. This stock shall be issued pursuant to Section 1244 of the Internal Revenue Code.

Such stock is, and shall remain, nonassessable.

The corporation shall not issue any stock to any person who is not duly licensed or otherwise legally authorized to practice medicine in the State of Idaho.

No shareholder of the corporation shall enter into a voting trust or any other type of agreement vesting another person with authority to exercise the voting power of any or all of his stock unless such person is duly licensed or otherwise legally authorized to practice medicine in the State of Idaho.

If any officer, shareholder, agent or employee of the corporation who has been practicing medicine becomes legally disqualified to render such professional service within this state, said officer, shareholder, agent or employee shall sever all employment with, and financial interest in this corporation forthwith.

No shareholder may sell or transfer shares in the corporation except to another individual who is eligible to practice medicine in the State of Idaho, and such sale or transfer may be made only after the same shall have been approved at a shareholder's meeting especially called for that purpose.

ARTICLE VI

CAPITAL STOCK

The amount of capital stock actually subscribed by the persons whose residences are hereinafter set forth appear opposite the names of said persons as follows, to wit:


