The undersigned, in order to form a Non-Profit Corporation under the Provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State. Article of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation of Idaho, do by certify:

- Article 1:** The name of the corporation shall be: Helping Hearts & Hands Inc.
- Article 2:** The purpose for which Helping Hearts & Hands is organized is a food bank, pregnancy resource Center, parenting classes, helping elderly, Children and battered women. Helping Hearts & Hands is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- Article 3:** The street address for Helping Hearts & Hands is 426 Main Street Gooding Idaho 83330 which is in the city of Gooding and the county of Gooding. Registered Agent Theresa K. Patterson 426 Main ST Gooding ID
- Article 4:** The initial trustees, Board of Directors are:

- Article 5:** The name of the incorporator is Theresa K. Patterson 1547 South 1700 East Gooding, ID 83330. No part of the net earnings of Helping Hearts & Hands Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Two hereof. No substantial part of the activities of Helping Hearts & Hands Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of the articles, Helping Hearts & Hands shall not carry on any other activities not permitted to be carried on (a) by a corporation

exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding sections of any future federal tax code.


Article 7: Helping Hearts & Hands Inc. does have voting members.

Article 8: Upon dissolution of Helping Hearts & Hands Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the state of Idaho in the City of Gooding, Gooding County, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such operated exclusively for such purposes.
