ARTICLES OF INCORPORATION
OF
HAWN-SMITH, INC.

The undersigned, acting as the incorporators of a corporation under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I.

The name of this corporation shall be Hawn-Smith, Inc.

ARTICLE II.

The period of existence and duration of the life of this Corporation shall be perpetual.

ARTICLE III.

This Corporation is organized for the purpose of the transaction of all or any lawful business for which Corporations may be incorporated under the Idaho Business Corporation Act, which may include, but is not limited to, the manufacture, sale, distribution, preparation, retail or wholesale, marketing, public sales and service, personal service contracts, rentals, property management, land and equipment acquisition and any other lawful business transaction.

ARTICLE VIII.


