



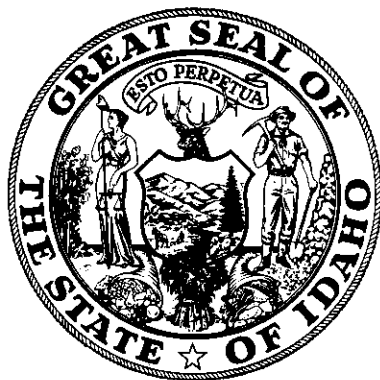
CERTIFICATE OF INCORPORATION

RICHARD COLTON, MARGARET COLTON, ROBERT WACHTER and SHIRLEY WACHTER, being over the age of eighteen (18) years and citizens of the United States of America hereby make and file these Articles of Incorporation for the purpose of establishing a corporation for the transaction of the business and the promotion and conduct of the objects and purposes herein stated under the laws of the State of Idaho, and hereby certify as follows:

ARTICLE ONE: The name of this corporation (hereinafter referred to as "The Corporation") is Alpine Lumber Company, Inc.

ARTICLE TWO: The Corporation shall have perpetual existence.

ARTICLE THREE: The purpose for which The Corporation is organized is the transaction of any lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, and generally to carry on any business and have all powers conferred by the State of Idaho upon a corporation formed under its laws.

ARTICLE FOUR: The Corporation shall have the authority to issue ONE HUNDRED (100) shares of common stock, without par value, which shall qualify as Section 1244 Stock, Internal Revenue Code. All of said stock shall be voting common stock of one single class having equal rights, powers and preferences.

ARTICLE FIVE: The incorporators of The Corporation are RICHARD COLTON, 6200 Cloverleaf Road, Post Falls, Idaho 83854; MARGARET COLTON, 6200 Cloverleaf Road, Post Falls, Idaho 83854; ROBERT WACHTER, North 7000 First Street, Post Falls, Idaho 83854; and SHIRLEY WACHTER, North 7000 First Street, Post Falls, Idaho 83854.

ARTICLE SIX: The initial registered office of The Corporation shall be 4885 Industrial Way, Industrial Park, Coeur d'Alene, Idaho 83814, and the initial registered agent at said address is Richard Colton.

ARTICLE SEVEN: The number of directors constituting the initial board of directors shall be FOUR (4). The names and addresses of the initial directors who will serve as directors until the first annual meeting of shareholders or until their successors are elected and qualify are those individuals set out in ARTICLE FIVE herein.

ARTICLE EIGHT: The officers of The Corporation shall be a president, a treasurer, a secretary and one or more vice presidents. All of said officers shall be elected by the board of directors and shall hold office and have the powers as respectively specified in the corporate by-laws.

ARTICLE NINE: Subject to the power of the shareholders to amend or repeal the by-laws, the board of directors shall have the authority to amend the by-laws, define the powers and duties of the corporate officers and provide for such other matters as they deem essential or convenient to the conduct of The Corporation's affairs, insofar as said authority is consistent with the laws of the State of Idaho and these Articles of Incorporation.
