

ARTICLES OF INCORPORATION

OF

DICKERSON & CO., MFG., INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is DICKERSON & CO., MFG., INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The corporation shall have authority to issue One Hundred Thousand shares of common stock, all of one class, with a par value of ten dollars (\$10.00) per share.
