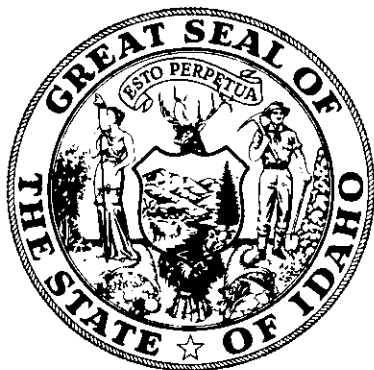

ARTICLES OF INCORPORATION

OF

THE BRIDGE, INC.

The undersigned incorporator, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Idaho, does hereby certify:

ARTICLE I.

The name of the Corporation shall be THE BRIDGE, INC.

ARTICLE II.

The corporation is to be a non-profit corporation under the Non-Profit Corporation Law of Idaho.

ARTICLE III.

This Corporation shall be perpetual in duration.

ARTICLE IV.

The purpose of this Corporation shall be a refuge for the treatment, education, rest and rehabilitation of persons afflicted with alcoholism and other dependencies.

ARTICLE V.

The Corporation shall have a Board of Directors. The Board of Directors shall manage the affairs and business of the Corporation, and its funds and property, and shall make, authorize or ratify all contracts of the Corporation not inconsistent with the provisions of the Articles of Incorporation and Bylaws, and section 30-314(c) of the Idaho Code. The Board of Directors shall employ an administrator who shall be responsible to the Board of Directors for the overall operation of THE BRIDGE, INC.

ARTICLE VI.
