ARTICLES OF INCORPORATION

OF

L. L. JONES, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned residents of the State of Idaho and citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end we do hereby certify:

I

The name of this corporation shall be:

L. L. JONES, INC.

II

The purposes for which the corporation is formed are as follows:

a. To buy, sell, exchange, purchase, lease, rent or otherwise to acquire or deal in farming properties, including real estate, machinery, tools and equipment; to buy, build, construct or otherwise acquire buildings, dwellings, plants and warehouses.

b. To plant, sow, cultivate and harvest grains, hay, forage, vegetables, fruit and all kind of farm produce and

products; to breed, raise, buy, pasture, prepare for market, exhibit, sell and deal in cattle and livestock of all kinds, and to conduct a general cattle and farming business.

c. To acquire by purchase, subscription or otherwise, and to own, hold, sell, negotiate, assign, deal in, exchange, transfer, mortgage, pledge or otherwise dispose of any shares of capital stock, script, bonds, mortgages, securities or other evidences of indebtedness, issued or created by any person or by any other corporation, joint stock company or association, public or private; and to exercise any and all rights, powers or privileges of ownership, including the right to vote thereon.

d. To purchase, or otherwise acquire, and to hold, own, maintain, work, develop, sell, lease, exchange, hire, convey, mortgage or dispose of or to deal in real estate, lands and leaseholds and any interests, estate and rights in real property and any personal or mixed property and any franchises, rights, licenses or privileges necessary, convenient or appropriate for any of the purposes herein expressed.

e. To do each and everything necessary, convenient, requisite or desirable, directly or indirectly, which would promote the interests of the Company and improve or enhance the value of its property.

### III

The period of existence of this corporation shall be perpetual.

### IV

The location and post office address of the registered office of this corporation shall be Route #1, Malad City, Idaho, 83252.

The total authorized capital stock of this corporation shall be \$250,000.00 divided into 2,500 shares of \$100.00 each.
