ARTICLES OF INCORPORATION

OF

GRAND TETON FOREST PRODUCTS INC.

The undersigned, acting as incorporator, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be Grand Teton Forest Products Inc.

ARTICLE II

The corporation is to have perpetual existence.

ARTICLE III

The purpose for which said corporation is formed is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act. The nature of the business of the corporation, while not limited to the following, shall be to own and operate a wood products manufacturing, distribution, and sales business.

ARTICLE IV

The capital stock of the Corporation shall be six million (6,000,000) shares of common stock, without par value. There shall be no preferred stock.

ARTICLE V

Thirty thousand (30,000) shares of stock of the Corporation will be initially issued and divided in proportion to ownership.

ARTICLE VI

The stock of the Corporation will be non-transferrable except unon an affirmative vote of the majority of the shareholders. In the event of change of ownership or cashout of any principal, the remaining principals will have the right of first refusal.

ARTICLE X

The names and addresses of each subscriber to these Articles of Incorporation and the initial proportion of ownership and net profits of the Corporation are as follows: Jan H. Brallier, 268 West Center, Victor, Idaho 83455, 90%; J. Dean Stevens, Idaho Technology Ventures, 2300 North Yellowstone Highway, Idaho Falls, Idaho 83401, 10%. Idaho Technology Ventures shall be granted an increasing equity position as follows:

When annual sales reach \$5 million, the ITV equity shall increase to 15% of the stock, at annual sales of \$20 million ITV shall own 20% of the stock, at annual sales of \$35 million ITV shall own 30% of the stock, and at annual sales of \$50 million ITV shall own 40% of the stock.

Annual sales	ITV Ownership
\$5 million	15% of stock
\$20 million	20% of stock
\$35 million	30% of stock
\$50 million	40% of stock

ITV shall receive a management fee of ten percent (10%) of gross sales, as total gross sales exceed \$5 million the fee shall reduce to 7%, as total gross sales exceed \$10 million the fee shall reduce to 5% and remain at 5% thereafter.
