

Articles of Incorporation.

The undersigned citizens of Silver City Idaho Territory desiring to form a Corporation (for the purpose of supplying the City of Silver with water for various purposes,) under and in pursuance of the laws of the Territory of Idaho, do hereby certify and declare as follows. —

First.

The name of said Corporation shall be the "Silver Water Company".

Second.

The object of the said Corporation shall be to build reservoirs to hold a supply of water for the various uses of the citizens of Silver City and vicinity (in the County of Emery, and to conduct the same to the various places needed, by a proper system of ditches Iron pipes, wooden pipes and hose and to sell the same for a proper compensation.

Third

The amount of the Capital Stock of said Corporation shall be fifty thousand dollars in United States currency, which shall be divided into one thousand shares of fifty dollars each.

Fourth. The said Corporation shall exist
for the term of fifty years.

Fifth. The principal place of business of
said Corporation shall be in
the City of Silver County of Owyhee
and Territory of Idaho.

Sixth. The number of Trustees who shall
manage the concerns of said Cor-
poration for the first three months,
shall be five and the following are
the names of the said trustees
J. F. Lye, W. F. Sommercamp,
H. A. Rogers, Peter Donnelly,
and W. B. Crane.

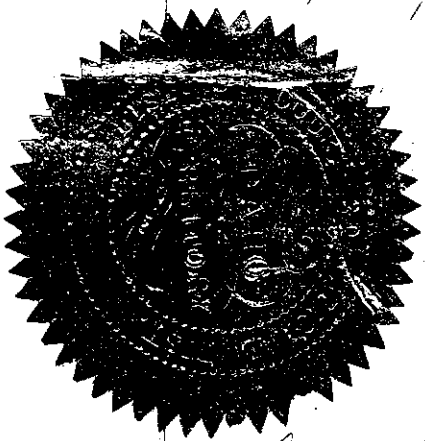
