SECOND ARTICLES OF AMENDMENT AND

CHANGE OF AUTHORIZED SHARES OF STOCK

BE IT KNOWN THAT SHORE CLUB LODGE, INC., a corporation, organized and existing under and by virtue of the laws of the State of Idaho, does hereby make and execute the following Articles of Amendment and Change of Authorized Shares of Stock and does hereby certify in accordance with Chapter 1. Secs. 29-145 to 29-148, inclusive, as follows:

That at a special meeting of the stockholders of said corporation duly called, convened and held in the manner provided by law and the By-Laws of said corporation on the 25th day of — May, 1946 at 6:30 o'clock A.M., at the office of the company, Crystal Ballroom, Boise Hotel, Boise, Idaho, by an affirmative vote of 2875 — shares of the common stock of the corporation the capital stock of the corporation was voted to be increased from \$500,000.00 to \$850,000.00, and the following resolution was adopted:

RESOLVED, That the capital stock of the corporation be increased from \$500,000.00 to \$850,000.00, and that the Articles of Incorporation of the company be amended by amending Article Fifth thereof to read as follows:

FIFTH

The amount of the capital stock of this corporation shall be, and is, Eight Hundred Fifty Thousand Dollars (\$850,000.00) divided into Eight Thousand Five Hundred (8,500) shares of the par value of One Hundred Dollars (\$100.00) each.

RESOLVED FURTHER That the President and Secretary of the Company be, and they are hereby directed and employed to cause a proper certificate of such amendment to the Articles of Incorporation of the Company to be executed and filed with the Secretary of State of Idaho and with the Recorder of Valley County of said State in accordance and in compliance with the statutes of the State of Idaho in such case made and provided.
