ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all being citizens of the United States of America, and all being persons of full legal age, have this day voluntarily associated ourselves together for the purpose of forming a domestic corporation, under and pursuant to the laws of the State of Idaho, and we do hereby certify as follows:

ARTICLE I

CORPORATE NAME

That the name of this corporation shall be "A" COMPANY, INC.

ARTICLE II

PURPOSES

- (a) To form a private profit making corporation.
- (b) To engage in the manufacture, sale, leasing, marketing and servicing of goods, merchandise and services owned or produced by the corporation.
- (c) To engage a sales force by employment or sub-contract and to employ such other personnel as may be convenient or necessary to the furthering of corporate purposes.
- (d) To conduct business in the State of Idaho, in any sister state of the United States, or any foreign country in the world.

(e) To engage in any business relative to marketing goods and merchandise, such as the erection of buildings, owning and leasing the same, the purchase and leasing of vehicles, aircraft, or ships, or any convenient means of conveyance; and to enter into advertising ventures.

(f) To negotiate and enter into contracts with other corporations.

(g) To deal in personal and real property and to mortgage, borrow, hypothecate, buy, sell, transfer or encumber the same in any form that may be convenient to the corporate business.

(h) To issue certificates of stock and to deal in its own corporate stock or the stock of any other corporation.

(i) To own, buy, sell, hypothecate, borrow, loan and otherwise enter the money market to obtain capital or operating funds for the corporate purposes or to produce capital funds for other corporations or individuals and to use any of its corporate assets as security therefor.

(j) To establish bank accounts, engage in non-related investments and to draw on accounts thus established at will.

### ARTICLE III

#### EXISTENCE

This corporation shall have a perpetual existence unless sooner dissolved by unanimous vote of the stockholders or by operation of law.

### ARTICLE IV

#### ADDRESS

ARTICLE V

STOCK

(a) The total authorized number of shares of corporate stock shall be 1,000 shares, with each share having a par value of \$10.00.

(b) There shall be but one class of stock and each share shall have one vote at the annual stockholders' meeting and no share shall be assessable.

(c) No issued shares are to be sold or transferred without the approval of a two-thirds' vote of approval by the Board of Directors, and this restriction will be printed on each certificate.

(d) Any stock certificate issued but held in escrow and not paid for shall not be voted at any time for any purpose. Only fully paid shares shall be allowed a vote at any shareholders' meeting.

ARTICLE VI

INCORPORATORS - STOCK SUBSCRIPTIONS

ARTICLE VII

OFFICERS

The officers of this corporation shall consist of a Board of Directors to be elected by the shareholders consisting of not less than three nor more than seven directors

to be elected at the stockholders' organizational meeting and at each stockholders' annual meeting thereafter. The Board of Directors shall at their organizational meeting and annual meetings elect a chairman of the board, a corporate president and one or more vice-presidents. All other corporate officers shall be appointed by the Board of Directors as may be convenient and necessary. Board meetings, elections, duties and replacement of officers shall be determined by the corporate by-laws.

#### ARTICLE VIII

##### BY-LAWS

The corporate Board of Directors shall, at their organizational meeting, or as soon thereafter as may be convenient, adopt such by-laws for governing this corporation as they may deem expedient so long as they are not inconsistent with these articles.


#### ARTICLE IX


