

ARTICLES OF INCORPORATION

The undersigned, acting to incorporate a corporation under the Idaho Business Corporation

Act, adopt the following Articles of Incorporation for such corporation:

- 1. NAME: The name of the corporation is Corey's Tyhee Automotive, Inc.
- 2. DURATION: The period of its duration is perpetual.
