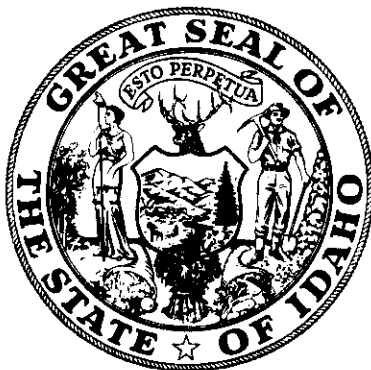

ARTICLES OF INCORPORATION

The name of the corporation shall be "CUSTOM RECORDING & SOUND, INC."

The corporation is not a non profit corporation.

The period of duration of the corporation shall be perpetual.

The purpose for which the corporation is organized is as follows:

To engage in the wholesale and retail sale of recording and sound tape and related supplies; the rental and sale of sound and recording (audio-video) equipment; the operation of audio and video recording studios on location and within established studios in any other location whatsoever; the ownership of real and personal property, the rental and installation of sound and video equipment in private and public locations and facilities; and the carrying out of any lawful pursuit not prohibited by Title 30, Chapter 1, Idaho Code - Idaho Business Corporation Act of 1979, including but not restricted to Section 30-1-4 of said Act.

The aggregate number of shares which the corporation shall be authorized to issue and the class of such stock shall be as follows:

Class "A" Capital Stock 10,000 shares at \$1.00 each par value.

The street address of the corporation's initial registered office shall be 3907 Custer Drive, Boise, Idaho 83705 and its initial registered agent of process shall be Donald K. Cederstrom at such address.

The number of directors constituting the corporation's initial board of directors shall be three (3). Their names and addresses are as follows:

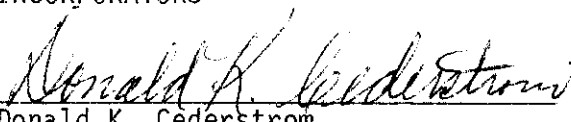

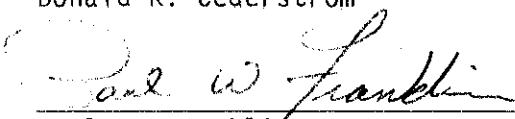
The corporation shall become effective upon issuance of the Corporate Charter by the State of Idaho.

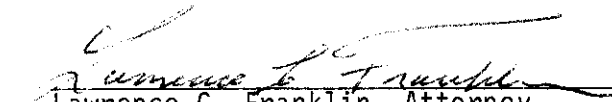
