The undersigned incorporators, desiring to form a corporation pursuant to the provision of the Idaho Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE. Name. The name of the corporation is Atchley, Inc.

ARTICLE TWO. <u>Duration</u>. The period of duration of the corporation is perpetual.

ARTICLE THREE. <u>Purposes</u>. The purpose of the corporation is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

## ARTICLE FOUR. Stock.

- (a) The total number of shares of stock the corporation shall have authority to issue is 100,00 shares of common stock all of one class, without par value.
- (b) No Shareholder shall have any preemptive right to acquire unissued or treasury shares of the corporation.
- (c) The transfer of shares of stock of the corporation shall be restricted as set forth in the Bylaws of the corporation or in any agreement between the corporation and its shareholders.

ARTICLE FIVE. <u>Two-Thirds Shareholder Vote required</u>. At least two-thirds(2/3) of the shares entitled to vote, represented in person or by proxy, shall be required to approve or authorize any of the following:

- (a) The public offering of any shares of common stock or other securities of the corporation.
- (b) A merger of the corporation with or into any corporation or entity.
- (c) The sale of all or substantially all of the assets of the corporation.
- (d) The compensation to be paid directors of the corporation.
- (e) The amendment of the Articles of Incorporation or Bylaws of the corporation.
