2 with any business, occupation, industry or employment, and to
3 dispose of, sell, loan, pledge, hire and use in any and all
4 lawful ways the information, statistics, facts and circumstances
5 so obtained and acquired.

7 (c) To receive, acquire, hold, purchase, dispose of,
8 convey, mortgage and/or lease real and personal property; to
9 dispose of, sell, lease, assign, transfer, mortgage and/or
10 convey rights, privileges, franchises, real or personal property
11 of the corporation, other than its franchise of being a corpora-
12 tion, and to acquire, purchase, guaranty, hold, mortgage, own,
13 vote, sell, pledge and/or otherwise dispose of and deal in
14 shares, bonds, securities and debentures and other evidences of
15 indebtedness of other corporations, domestic or foreign.

16
17 (d) To enter into, make, perform and carry out contracts
18 of every kind and for any lawful purpose, without limit as to
19 amount, with any person, firm, association, corporation,
20 municipality, state or government, or any subdivision, district
21 or department thereof.

23 (e) To do any and all such other acts, things, business
24 or businesses in any manner connected with or necessary,
25 incidental, convenient or auxiliary to any of the objects here-
26 inbefore enumerated, or calculated, directly or indirectly, to
27 promote the interest of the corporation, and in carrying on
28 its purposes, or for the purpose of attaining or furthering
29 any of its business.

31 (f) To exercise all authority conferred upon corporations
32 by Sec. 30-114 of the Idaho Code of 1947 and in addition
thereto to purchase its own stock and to enter it upon its books

1 as treasury stock or to cancel it or to re-issue it and in
2 general to deal and trade in its own stock.

3 (g) The purposes specified herein shall be construed as
4 purposes and powers and shall be in no wise limited or restricted
5 by reference to, or inference from, the terms of any other clause
6 in this or any other article, but the purposes and powers
7 specified in each of the clauses herein shall be regarded as
8 independent purposes and powers and the enumeration of specific
9 purposes and powers shall not be construed to limit or restrict
10 in any manner the general terms or general powers of the corporation.
11

12 (h) To borrow and loan money in connection with the herein
13 stated purposes, with or without securities therefor.
14

16 The corporation is to have perpetual existence subject
17 only to the dissolution in the manner as by law provided.
18

19 IV

20 The location and postoffice address of the registered
21 office of the corporation is 112 North Lincoln, Jerome, Jerome
22 County, State of Idaho.

24 The amount of the capital stock of this corporation shall
25 be, and is, Twenty-five Thousand and No/100 Dollars (\$25,000.00)
26 divided into 250 shares of par value of \$100.00 per share.

7 The private property of the stockholders of the corporation
8 shall not be subject to the payment of corporate debts to any
9 extent whatever, and the shares of the corporation shall not be
10 subject to assessment for the purpose of paying expenses,
11 conducting business or paying debts of the corporation.

14 The number of Directors of the corporation shall be as
15 specified in the By-Laws, and such number may from time to time
16 be increased or decreased in such manner as may be prescribed in
17 the By-Laws, provided the number of Directors of the corporation
18 shall not be less than three. In case of any increase in the
19 number of Directors, the additional Directors may be elected by
20 the Directors then in office, and the Directors so elected shall
21 hold office until the next annual meeting of the stockholders and
22 until their successors are elected and qualified.

25 The Board of Directors is expressly authorized to repeal
26 and amend the By-Laws of the corporation and to adopt new By-Laws,
27 and the corporation reserves the right to amend, alter, change
28 or repeal any provision contained in these Articles of Incorpora-
29 tion in the manner now or hereafter prescribed by law by a
30 majority vote of the shareholders represented in person or by
31

1 proxy at any annual meeting of the sharehlders or at any meeting
2 duly called for that purpose, except where the laws of the State
3 of Idaho otherwise provide.
