## KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, being a natural person and of full age and citizen of the United States, by these presents for the purpose of forming a corporation pursuant to the corporation laws of the State of Idaho, do hereby certify as follows:

Ι

That the name of the corporation is IT'S LEGAL, INC.

II

That the purpose for which said corporation is formed is:

The private property of the stockholders of the corporation shall not be subject to the payment of the corporation debts to any extent whatever, and the shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business or paying debts of the corporation or for any

The number of directors of the corporation shall be as specified in the By-Laws, and each number may from time to time be increased or decreased in such manner as may be prescribed in the By-Laws, providing the number of directors shall not be less than one.

The Board of Directors is expressly authorized to repeal and amend the By-Laws of the corporation and to adopt new By-Laws, and the corporation reserves the right to amend, alter, change, and repeal any provision contained in these Articles of Incorporation in the manner now or hereafter prescribed by law by a majority vote of the shareholders represented in person or by proxy at any annual meeting of the shareholders or at any meeting duly called for that purpose except where the laws of the State of Idaho otherwise provide.
