**INTERIM FIRST BANK OF IDAHO, AN IDAHO SAVINGS BANK
ARTICLES OF INCORPORATION**

Section 1. Corporate Title. The full corporate title of the savings bank is "Interim First Bank of Idaho, an Idaho Savings Bank."

Section 2. Office and Registered Agent. The registered agent is William H. Thomas and the home office of the corporation is located at 702 W. Idaho, Suite 310, Boise, Idaho.

Section 3. Duration. The duration of the savings bank is perpetual.

Section 4. Purpose and Powers. The purpose of the savings bank is to facilitate the Conversion and Reorganization by which Interim First of Bank ("Interim") will be formed by Sun Valley Bancorp as an Idaho stock savings bank and merged with and into First Bank of Idaho (the "Bank") with the Bank being the surviving entity.

Section 5. Capital Stock. The aggregate number of shares that Interim shall have the authority to issue is 100 shares of common stock of par value \$5.00 per share.

Section 6. No Cumulative Voting. The shareholders of the corporation shall not be entitled to accumulate their votes for the election of directors.

Section 7. Preemptive Rights. The holders of capital stock of the savings bank shall not be entitled to preemptive rights with respect to any share of the savings banks which may be issued.

Section 8. Directors. The savings bank shall be under the direction of a board of directors. The authorized number of directors, as stated in the savings bank's bylaws, shall consist of not fewer than five nor more than fifteen as may be from time to time determined by the Board of Directors.
