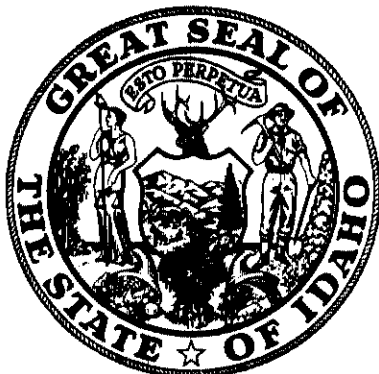

ARTICLES OF INCORPORATION

OF

JODY McDANIEL INSURANCE AGENCY, INC.

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned being a natural person over the age of eighteen (18) years, do hereby form a general business corporation under the laws of the State of Idaho as contained in Title 30 of the Idaho Code entitled "Idaho Business Corporation Act", and to that end do hereby set forth:

1. The name of the corporation is:

JODY McDANIEL INSURANCE AGENCY, INC.

2. The period of duration of this corporation shall be perpetual.

3. The purposes for which this corporation is organized:

(a) Primarily to engage in the business of an insurance agency and to act as an agent for State Farm Insurance Companies in soliciting and receiving applications and collecting premiums for fire, casualty, health, liability, automobile, life and all other insurance or insurance products for which a corporation may be licensed as an insurance agency, and to conduct such other business as may be delegated to insurance agents by State Farm Insurance Companies.

11 corporation shall have authority to issue is 100, having no  
12 par value. All of said stock shall be known as common stock


