The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is Lundquist Trucking Inc.
(hereafter "Corporation").

ARTICLE II

The purposes for which this Corporation is organized are as follows:
