

ARTICLES OF INCORPORATION



The undersigned, a majority of whom are citizens of the United States, desiring to form a non-profit corporation under the Idaho Non-profit Corporation Act, do hereby certify:

- That the name of the corporation shall be the Junction City Arts Council Limited.
- 2. The initial registered agent of the corporation shall be Jeni Zech; the initial registered office of the corporation shall be 316 South Apple, Shoshone, Idaho; the mailing address for the corporation shall be P. O. Box 788, Shoshone, Idaho 83352.
- 3. The duration of the corporation shall be perpetual.

- 4. The purpose or purposes for which the corporation is organized are: charitable, educational, and civic, including but not limited to the following: a) to foster an environment in which the arts can flourish; b) to develop arts programs in cooperation with local civic and merchants associations, with an emphasis on economic development; c) to work with the educational systems to provide arts programs for our young people; d) to provide economic opportunities for individual artists; e) to develop and present programs in the arts which encourage the appreciation and participation by people of all ages in our community; f) to provide cultural alternatives to our community; g) to present the art as an integral part of our lives; h) to perform all other acts necessary or incidental to the above. Notwithstanding any other provisions of these Articles, the purposes of the corporation are exclusively charitable, and the organization shall not engage in any activities expressly prohibited by Section 501(c)(3) of the Internal Revenue
- 5. The names and addresses of the persons who are the initial directors of the corporation are:

6. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers or other private persons, except that the corporation may pay reasonable compensation for services rendered and make payment and distributions in furtherance of the purposes set forth in these articles. No substantial part of the activities of this corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, nor shall it participate in or intervene in any political campaign on behalf of any candidate for public office.

7. In the event of dissolution, the corporation shall, after payment of all liabilities, distribute any remaining assets to an organization or organizations which at the time are exempt from taxation under Section 501(c)(3) of the Internal Revenue Code.
