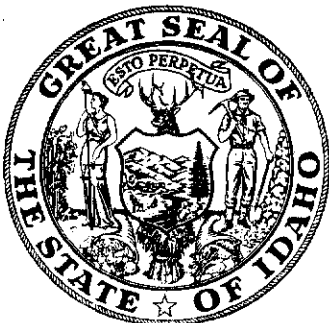

ARTICLES OF INCORPORATION

OF

SUPERIOR POTATO SYSTEMS, INC.

The undersigned, acting as incorporators under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is **SUPERIOR POTATO SYSTEMS, INC.**

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is the transaction of any and all other lawful business for which corporations may be incorporated within the State of Idaho.

FOURTH: Capital stock shall be FIFTY THOUSAND (\$50,000.) DOLLARS. The aggregate number of shares of which the corporation shall have authority to issue is FIVE THOUSAND (5,000) shares at a par value of TEN (\$10.) DOLLARS.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are as governed by the By-Laws.

SIXTH: There shall be a restriction on the transfer of any interest of the stock of the Corporation. Restriction on the transfer of interest shall be governed by provisions as set forth in the By-Laws.


