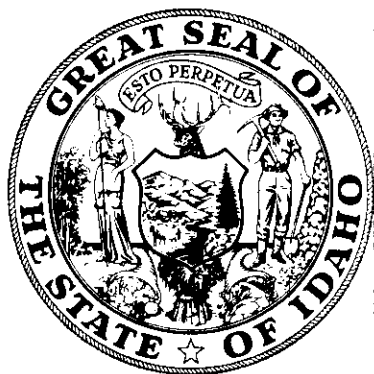

Pursuant to Sections 30-1-59 and 30-1-64 of the Idaho Business Corporation Act, the undersigned corporation, pursuant to a resolution duly adopted by its incorporators, hereby adopts the following restated Articles of Incorporation by adding a new "Article Eight".

ARTICLE ONE

The name of the corporation is STOP SMOKING CENTER OF EASTERN IDAHO, INC.

ARTICLE TWO

The purposes of the corporation are the operating of businesses for the provision of services to assist smokers to terminate their smoking habit and the transaction of any or all other lawful business for which corporations may be incorporated under the laws of the State of Idaho.

ARTICLE THREE

The period of duration of the above corporation is perpetual.

ARTICLE FOUR

The total number of authorized shares of stock of the above corporation is one thousand (1,000), consisting of one (1) class and having a par value of ONE AND NO/100 DOLLARS (\$1.00) per share.

ARTICLE FIVE

At each election for directors by shareholders, every shareholder entitled to vote at such election shall have the right to vote, in person or by proxy, only the number of shares owned by him, and no cumulative voting of shares shall be permitted, and no shareholder shall multiply or distribute his votes with respect to the directors being elected.

The foregoing restated Articles of Incorporation correctly set forth without change the corresponding provisions of the Articles of Incorporation as heretofore amended, and supersede the original Articles of Incorporation and all amendments thereto.
