The undersigned officers, having received approval of the various corporations involved have hereby adopted the following Articles of Merger.

Article 1: Plan. Z T Corp. and its wholly owned subsidiaries: Zirbel Transport, Inc., Wood-By Products, Inc., and Gem Chip and Trading Co., Ltd, have adopted a plan of merger effective September 1,1995.

Z T Corp. owns all the issued and outstanding shares of Zirbel Transport, Inc, Wood-By Products, Inc. and Gem Chip and Trading Co., Ltd. The corporations, through their duly authorized officers, have been instructed to merge the subsidiary corporations into the parent pursuant to Section 30-1-75 of the Idaho Code, as amended.
