
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION  
OF  
INSIGHT DISTRIBUTING, INC.

The undersigned, acting as the incorporators of a corporation under the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation shall be Insight Distributing, Inc.

ARTICLE II

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III

This corporation is organized for the purpose of the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act. These purposes may include, but are not limited to purchasing, distributing, leasing, selling, cleaning, and repairing restaurant equipment and supplies. The corporation may conduct business and carry out its purposes in any state, territory, district, or possession of the United States of America or any foreign country.

ARTICLE IV

The total number of shares of the corporation shall consist of 100 shares of common stock. No par value is attached to the

shares. All shares shall be of one class denoted Common Stock. Each share is entitled to one (1) vote.

#### ARTICLE V

There are no provisions denying preemptive rights.

#### ARTICLE VI

Provisions for the regulation of the internal affairs of the corporation are to be set forth in the By-Laws of the corporation, which include restrictions on transfers of shares of this corporation.

#### ARTICLE VII

The address of the initial registered office of the corporation is 1723 West Ontario, Sandpoint, Idaho, 83864, and the name of the initial registered agent at such address is: S. K. Pearlstein.

#### ARTICLE VIII
