ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I

The name of the corporation is REBEL ENTERPRISES OF BOISE, INC.

II

The corporation is to have perpetual existence.

III

The corporation is organized for the primary purpose of merchandising and marketing magnetic media and accessory supplies and consumable inventory items, and for the purpose of transacting any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV

The authorized capital of the corporation consists of a single class of stock. The total number of authorized shares is 25,000 with a par value of \$1.00 and an aggregate par value of \$25,000.

V

The holders of shares of stock of the corporation are not entitled to pre-emptive rights to purchase additional shares of stock.

VI

The address of the initial registered office of the corporation is 2430 Overland Road, Boise, Idaho 83705.

VII

The name of the initial registered agent of the corporation at the corporate address is Ernest R. Anderson, Jr.

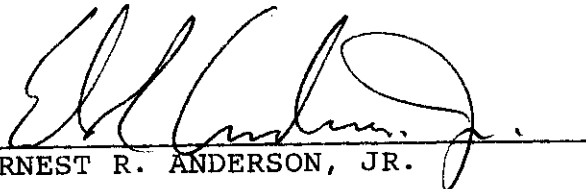
