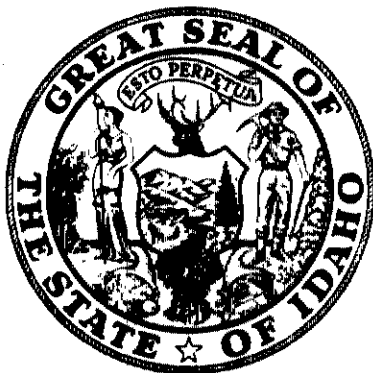

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is JADE AUTO CLINIC, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on September 12, 1979, in the manner prescribed by the Idaho Business Corporation Act:

Article IV has been amended to add as one of its purposes, the following:

h. To engage in the business of purchasing, acquiring, owning, leasing, selling, transferring, encumbering, generally dealing in, repairing, renovating, and servicing all types of new and used automobiles, trucks and other vehicles, including, but not limited to trailers, motor or mobile homes and recreational vehicles, and any parts or accessories used in connection therewith; and to engage in the business of purchasing, acquiring, owning, selling and generally dealing in all types of supplies used by all types of motor vehicles as above described, but not limited thereto.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 25; and the number of shares entitled to vote thereon was 25.
