ARTICLES OF INCORPORATION
OF
PAY-JEN CONSTRUCTION, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age and citizens of the United States of America, having voluntarily associated ourselves together to form a corporation for the purposes hereinafter stated pursuant to the Business Corporation Act of the State of Idaho, do hereby certify as follows:

I

The name of this corporation is: PAY-JEN CONSTRUCTION, INC.

II

The purposes for which this corporation is formed are:

(a) to engage in the business of construction of any and all types of buildings, structures, improvements or otherwise, and of every kind and description, upon real property owned by this corporation or by any other person, corporation, company, combination, or body politic in the world.

(b) to install and construct roads, highways, sidewalks, and any other improvements appurtenant to same; to clear land for any use; to crush rock or gravel for use in same, and do any and all other activities necessary to do construction work on roads, highways, sidewalks, or appurtenances thereto; to clear roads of any description in winter months of snow, ice, rock, or obstructions of any kind.

(c) to purchase, acquire, own, hold, lease, subdivide, plat, sell, exchange, mortgage or otherwise operate, handle, dispose of or deal in real property wherever located, in parcels or tracts of whatever size or description and the improvements thereon and appurtenances thereto; to erect or cause to be erected on any lands owned, held or occupied by the corporation, buildings or other structures with their appurtenances, and to rebuild, enlarge, alter or improve any buildings or other structures now or hereafter erected on any lands so owned, held or occupied, and to mortgage, sell, lease, or otherwise dispose of any lands or interests in lands and in buildings or other structures.

(d) to acquire, purchase, construct, own, lease, and operate trucks, and all other kinds of equipment of whatever description which is or might be necessary or convenient to any phase or part of the business of construction in its broadest meaning, and to sell, give away, or otherwise dispose of same.

(e) to enter into, make, perform and carry out contracts of every sort and kind which may be necessary or convenient for the furtherance of the business of this corporation, with any persons, firms, corporations, state, associations, territory or municipality in the world.

(f) to borrow money for the purpose of this corporation, without limit as to amount, and to issue bonds, debentures, notes or any other evidence of indebtedness, secured or unsecured, of this corporation, for the moneys so borrowed, or in payment for property acquired, or for any other objects or purposes of this corporation, or inconnection with its business, to secure payment of such debentures, notes or other obligations by mortgages, or deeds of trust or pledges or other liens upon any or all of the property of this corporation wheresoever situated.

(g) to loan money to further the purposes of this corporation on terms agreeable to this corporation.

(h) in general and without limitation of anything contained in the foregoing, to carry on any other business in connection with the foregoing.

III

This corporation shall have a perpetual existence.

IV

The location and post office address of the office of this corporation shall be Box 513, Hailey, Blaine County, Idaho.

V

This corporation shall be authorized to issue one class of shares, (common stock); the total number shall be 10,000 shares at a par value of \$1.00 per share, aggregate par value, \$10,000.00.

VI

The capital stock of this corporation shall be non-assesable, and the private property of the shareholders or incorporators shall not be liable for the debts, obligations or liabilities of this corporation. A director of this corporation shall not be required to be a holder of any shares of stock.
