The corporation is a nonprofit corporation

ARTICLE FOUR DURATION

The period of duration of this nonprofit corporation shall be perpetual.

ARTICLE FIVE CORPORATE PURPOSE

The conditions and regulations of membership and the rights and other privileges of the classes of membership shall be determined and fixed by the laws of the corporations.

ARTICLE EIGHT LIMITATION OF MEMBER'S LIABILITY

The private property of the members' of this corporation shall not be liabile for it's corporate debts.
