ARTICLES OF INCORPORATION

SUDS TAVERN, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is **SUDS TAVERN, INC.**

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The corporation is authorized to issue a total of Five Thousand (5,000) shares with a par value of \$1.00 per each share, consisting of One Thousand (1,000) shares to be designated "Voting Common Stock" and Four Thousand (4,000) shares to be designated "Nonvoting Common Stock." The shares of Voting Common Stock and Nonvoting Common Stock shall be identical in every respect except for the voting rights to which the holders thereof shall be entitled. Each share of Voting Common Stock shall entitle the holder thereof to one (1) vote on all matters submitted to the shareholders of this corporation for their approval. The shares of Nonvoting Common Stock shall not entitle the holders thereof to any voting rights, except for those to which they are entitle by law.

ARTICLE V

The corporation shall have the right to purchase, take, receive or otherwise acquire, hold, own, pledge, transfer and dispose of its own shares to make other distributions permitted by the laws of the state of Idaho to the extent of both its unrestricted and unreserved capital surplus.

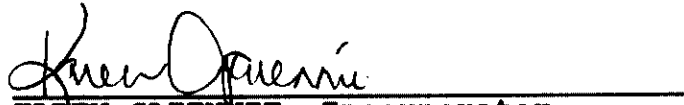
